

**PRECAUTIONARY STATEMENTS**

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION:** Harmful if swallowed. Keep away from children, domestic animals and pets.

**PERSONAL PROTECTIVE EQUIPMENT (PPE)**

All handlers (including applicators) must wear shoes, socks, and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

**User Safety Requirements**

Follow manufacturer's instruction for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash hands thoroughly after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet and change into clean clothing.

**TREATMENT FOR PET POISONING**

If animal eats bait, call veterinarian at once.

**NOTE TO PHYSICIAN OR VETERINARIAN**

**Anticoagulant Diphacinone:** If swallowed, this material may reduce the clotting ability of the blood and cause bleeding. For humans or dogs that have ingested this product and/or have obvious poisoning symptoms (bleeding or prolonged prothrombin times), give Vitamin K<sub>1</sub> intramuscularly or orally.

**ENVIRONMENTAL HAZARDS**

This product is extremely toxic to mammals and birds. Dogs, cats and other predatory and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten this bait. Do not apply directly to water. Do not contaminate water when disposing of equipment wash water or rinsate.

**ENDANGERED SPECIES CONSIDERATIONS**

Salt Marsh Harvest Mouse (*Reithrodontomys raviventris*). Do not use this product in critical habitat within 0.5 miles of salt marsh vegetation and/or brackish water wetlands which are located: 1) near or adjacent to San Pablo Bay and San Francisco Bay, or 2) in the Sacramento River below or adjacent to confluence of the Sacramento River and the San Joaquin River (California).

Morro Bay Kangaroo Rat (*Dipodomys heermanni morroensis*). Do not use this product in critical habitat within 2.5 miles of Baywood Park which is located on Morro Bay (California).

Giant Kangaroo Rat (*Dipodomys ingrens*). Follow the Interim Measures for protecting endangered species in the California Endangered Species Bulletin for the following California counties: Fresno, Kern, Kings, Merced, Monterey, San Benito, San Luis Obispo, Santa Barbara and Tulare (California).

To protect endangered kangaroo rats, use one of the modified stations (inverted "T" with "elbows" or platform stations) developed for this purpose in association with the California Department of Food and Agriculture and the California Department of Fish and Game. **ENDANGERED SPECIES CONSIDERATIONS** (Continued from other panel)

Tipton Kangaroo Rat (*Dipodomys nitratoideis nitratoideis*). Follow the Interim Measures for protecting endangered species in the California Endangered Species Bulletin for the following California counties: Kern, Kings and Tulare (California).

Fresno Kangaroo Rat (*Dipodomys nitratoideis exilis*). Follow the Interim Measures for protecting endangered species in the California Endangered Species Bulletin for the following California counties: Fresno, Kern, Kings, Madera and Merced (California).

Stephen's Kangaroo Rat (*Dipodomys stephensi*). Follow the Interim Measures for protecting endangered species in the California Endangered Species Bulletin for the following California counties: San Bernardino, San Diego and Riverside (California).

Pygmy Rabbit (*Cynomys parviden*). Do not use this within one mile of alfalfa fields.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal. **Pesticide Storage:** Store only in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

**Pesticide Disposal:** Wastes resulting from the use of this product may be placed in trash or delivered to an approved waste disposal facility.

**Container Handling:** Nonrefillable container. Do not reuse or refill this container. [Paper:] Dispose of empty container by placing in trash, at an approved waste disposal facility or by incineration.

**IMPORTANT:** Do not expose children, pets, or non-target animals to rodenticides. To help prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife.
3. Dispose of product container, and unused, spoiled and unconsumed bait as specified on the label.

**USE RESTRICTIONS:**

This product may only be used to control California Ground Squirrels (*Spermophilus beecheyi*) and Belding's Ground Squirrels (*Spermophilus beldingi*) at the following sites: vineyards, fruit tree orchards (stone and pome), nut tree orchards (only after harvest and during the dormant season) and in rangeland. Do not graze livestock or plant food or feed crops while bait is present.

**APPLICATION DIRECTIONS**

**HANDBAITING:** Wearing gloves, scatter about one handful (2 oz.) of bait evenly over 40 to 50 square feet near active burrows or runways. Retreat every other day for 3 to 4 applications.

**MECHANICAL BAITING:** Use a mechanical seed spreader calibrated to evenly spread 2 oz. of bait to cover 40 to 50 square feet near active burrows or runways. Retreat every other day for 3 to 4 applications.
