#### Specific Hazards Arising from the Chemical

Product is water-based and will not burn. However, if the water in the product has evaporated, there is an explosion potential of the remaining solid if dust becomes airborne. The minimum ignition temperature for a dust cloud is 714°F (379°C).

**Hazardous Combustion Products** Nitrogen oxides (NO<sub>x</sub>). Other unidentified toxic and/or irritating compounds.

**Protective equipment and precautions for firefighters**

As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear. Evacuate area of unprotected personnel.
